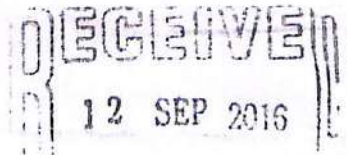

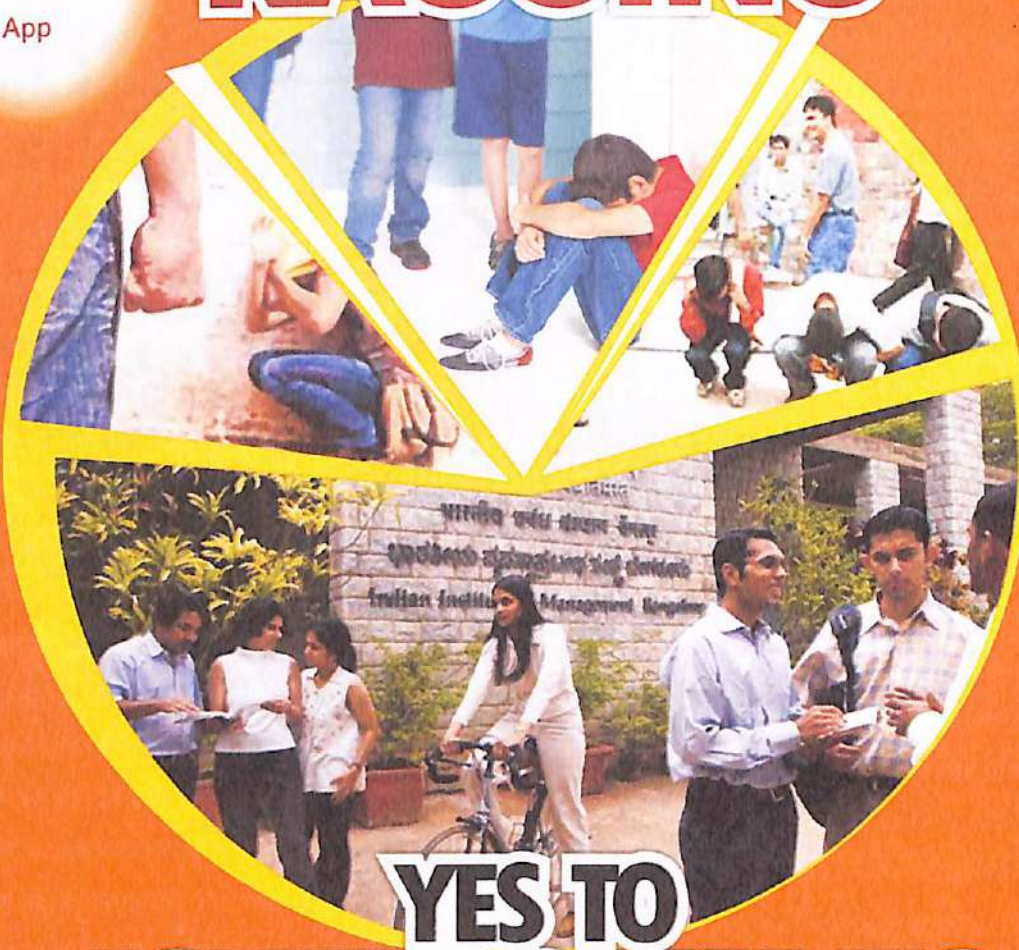

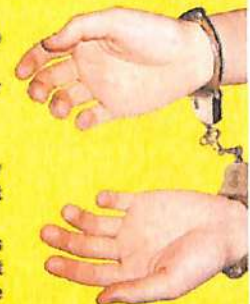
What is Ragging?

- Criminal Intimidation/wrongful Restraint
- Undermining Human Dignity
- Financial Exploitation/extortion
- Use Of Force

A STUDENT INDULGING IN RAGGING CAN BE:

- Cancellation of admission.
- Suspension from attending classes.
- Withholding/withdrawing Scholarship/Fellowship and other benefits.
- Debarring from appearing in any test/ examination or other evaluation process.
- Withholding results.
- Debarring from representing the institution in any regional, national or international meet, tournament or youth festival etc.
- **Collective punishment** : when the persons committing or abetting the crime of ragging are not identified the institution shall resort to collective punishment as a deterrent to ensure community pressure on potential ragger.







Report on Awareness Program On "RAGGING"

Awareness program on ragging was organised on 25th June 2018 at Silapathar Science College by Anti Ragging Committee of Silapathar Science College. The main objective of the awareness is to make the students aware of the grievousness of ragging and its aftermath effects.

The program started at 12 noon at college Seminar Hall and Junti Sonuwal, Lecturer of Assamese Department carried out the proceedings. The program was presided over by the Principal of Silapathar Science College. He drew out the negative effects of ragging and put forwarded different steps that can be utilized to minimize the ragging, the importance of the Anti-Ragging Committee and its functions were elaborated by him. He urged the students to concentrate on their studies and gave importance to maintain of class attendance.

The program was strched by Partha Nath Dutta, HOD of Physics who also cited various incidents reflecting the negativity of ragging and its effects. He suggested the need of mere introduction instead of ragging. He also demanded that the students must maintain regularity in attendance along with punctuality and discipline.

The awareness program came to an end with the speech of Debajit Patir, Asstt. Prof. Dept. of Physics, Member Secretary of Anti-Ragging Committee. He explained the severity of ragging and its hansh effects. He elaborated the function of Anti-Ragging Committee and the role played by the committee to eliminate the ragging in the campus. He also narrated the bylaws that has been incorporated to stop the ragging. Any of the students found indulged in ragging would be debarred by the institution or would be jailed or he or she would be defrimed fromadmitting in any College or University for further study. His or her scholarship would also be stopped if found guilty. With these lines the Member Secretary concluded his speech.

Lastly, just after the awareness program an icebreaking session was held with all the newcomers, seniors and the staff members of the college. Subject: Menace of ragging in higher educational institutions.

Sir/Madam,

This is in continuation to this office letter No. 1-15/2009 (Anti Ragging) dated 28.06.2013 & 2.08.2013 on the above subject. It is once again brought to your kind notice that ragging is a criminal offence and UGC has framed Regulations on curbing the menace of ragging in higher educational institutions in order to prohibit, prevent and eliminate the scourge of ragging. These Regulations are mandatory and all institutions are required to take necessary steps for its implementation in toto including the monitoring mechanisms as per provisions in the above Regulations and ensure its strict compliance.

Any violation of UGC regulations as cited above or if any institution fails to take adequate steps to prevent ragging or does not act in accordance with these Regulations, if fails to punish perpetrators of incidents of ragging suitably, UGC shall call for punitive action against institutions.

All institutions are requested to step up anti-ragging mechanism by way of adequate publicity through various mediums, action-packed anti-ragging committee and anti ragging squad, quick-response system, CCTV cameras at vital points, alarm bells, regular interaction and counseling, identification of trouble-triggers, prominence to anti-ragging in the institution's prospectus and information booklets/brochures, surprise inspection of hostels, students accommodation, Canteens, rest cum recreational rooms, toilets, bus-stands and any other measure which would augur well in preventing/quelling ragging and any uncalled for behavior/incident. The students and the parent/guardian community may also be made aware of the anti-ragging helpline, anti-ragging website, anti-ragging monitoring agency and all Universities/Colleges/Institutions should take necessary steps for its implementation under intimation to the UGC.

The student/parent ought to know whom to call and approach with alternative contact nos. when in difficulty. All the regulatory bodies and the educational institutions, including the universities funded by the UGC and the private universities, must ensure to UGC that they have a tight anti-ragging system.
