

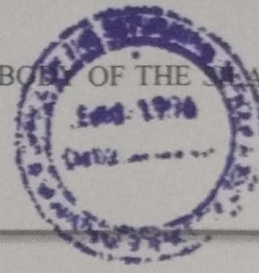

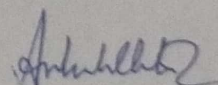

RULES & REGULATIONS FOR CANDIDATES, PROPOSERS, SUPPORTERS & VOTERS

1. It is hereby announced that the **CODE OF CONDUCT** for General Election to the formation of the **Executive Body of Silapathar Science College Students' Union, 2026-27** has come to effect w.e.f. **10-09-2026** and the present Executive Body of the Students' Union has become Non-functional. However, whenever called for, they shall assist and cooperate with the authority until the New Executive Body is formally formed and becomes functional.
2. **Candidates, Proposers and the Supporters** must have at least **75% of attendance** and must submit **Attendance Clearance Certificate** from the **Office of the Academic In-Charge, Silapathar Science College** and **FEE Clearance Certificate** from the **Office of the Principal, Silapathar Science College**.
3. **HS (2nd) Year** students are **debarred** from contesting in any portfolio.
4. **PG 1st Semester** Students and **UG 5th Semester** students only can contest in the **President** Portfolio.
5. Only **UG 5th Semester** students can contest in the **Vice-President** Portfolio.
6. Only **UG 1st & 3rd Semester** students can contest in the **General Secretary** Portfolio.
7. For **Assistant General Secretary** Portfolio, only **HS 1st Year** students can contest.
8. **Cultural Secretary** and **Social Service Secretary** Portfolios are **reserved for Female Students** only.
9. **Candidates, Proposers and Supporters** must pay their **up-to-date Tuition fees**.
10. **Candidates, Proposers and Supporters** must be in **prescribed college Uniform** during college hours, otherwise, the **NOMINATIONS**, of such defaulters, shall be **cancelled**.
11. Any **Comment against the Authority, candidate's misbehaviour** and **communal colouring** shall automatically render their **candidature cancelled**.
12. Any kind of **publishing** (flax, banner, leaflets, wall-writing etc.) is **strictly prohibited** in and outside the college campus.
13. A **Candidate cannot** be a proposer or supporter for another candidate.
14. A **Supporter or Proposer** can support or propose the candidature of **only one candidate**.
15. At the time of **submission of Nomination**, each **Candidate** must be **accompanied** none other than by the **Proposer and the Supporter**.
16. The **voters (students)** on the day of Election, i.e. 18-09-2026, must be in **prescribed COLLEGE UNIFORM** and must produce the **ID card or Valid Certificate** from the Authority.
17. Any **involvement with any political party, any outside Body/Union**, not belonging to the college during the **Code of Conduct** shall be treated strictly and may render the concerned candidate disqualified.
18. The election will be conducted as per the **Norms prescribed** by the **Lyngdoh Committee** in their recommendations for the election of student representatives in Universities and Colleges in India.
